Emily Rice, Workers Compensation Team Leader

How long have you been with The Fund?

I took over the Workers' Compensation Team Leader position in November 2024. I just celebrated 24 years of service with the Fund Administrator, Sedgwick.

What is a Workers Compensation Team Leader?

As the Workers Compensation Team Leader, I manage a team of 6 claims adjusters, that manage indemnity (time loss) and medical only claims. I am responsible for managing workers' compensation claims in Texas, ensuring compliance with state regulations, investigating incidents, determining eligibility for benefits, and resolving disputes, while providing guidance and coaching to the team members to achieve efficient claim resolution and optimal outcomes for both injured employees and employers. This requires in-depth knowledge of Texas Workers' Compensation laws and procedures managed by the Division of Workers' Compensation (DWC).

Tell me about your background.

Born and raised in Louisiana; my family moved to Texas while I was in high school. I graduated from Bryan Adam High School in Dallas, Texas. I began working in the mail room for an insurance company shortly after graduation. Little did I know that I would still be in the Insurance line of work 25 years later.

I soon left the mail room and began working in the Error Correction Unit, which entailed the daily correction of items submitted to the state electronically. This is where my love for reviewing and creating processes began. I transitioned to working as the Business Banking Analyst for a large National account for numerous years. From there, I went into handling claims as an adjuster. I handled claims for a few years and worked on various accounts/teams.

In 2012, I was promoted to the Compliance Specialist for Texas Workers' Compensation claims. In this role I was tasked with the creation of the Texas Compliance box. We
